This program is designed for physicians, residents, medical students, nurses, social workers, healthcare administrators, clergy, allied healthcare professionals, and others interested in the ethics of disaster response.

Keynote Speakers

Sheri Fink, MD, PhD, is the author of *Five Days at Memorial: Life and Death in a Storm-Ravaged Hospital* (Crown, 2013). Fink’s reporting has won the Pulitzer Prize, the National Magazine Award, and the Overseas Press Club Lowell Thomas Award, among other journalism prizes. Most recently, her coverage of the 2012 hurricane season and its effects on the health care systems of New York City and New Orleans won the Mike Berger Award from Columbia Journalism School and the beat reporting award from the Association of Health Care Journalists in 2013. Her story “The Deadly Choices at Memorial,” co-published by ProPublica and the New York Times Magazine, chronicled decisions made by the medical staff of one New Orleans hospital in the desperate days after Hurricane Katrina.

Dr. Fink is a Senior Fellow at the New America Foundation and a former relief worker in disaster and conflict zones. She received her M.D. and Ph.D. from Stanford University. Her first book, *War Hospital: A True Story of Surgery and Survival* (PublicAffairs), is about medical professionals under siege during the genocide in Srebrenica, Bosnia-Herzegovina.

Karen Remley, MD, MBA, FAAP, is the Founding Director of the recently established EVMS M. Foscue Brock Institute for Community and Global Health. Dr. Remley served as Virginia Commissioner of Health for more than four years. Prior to her initial appointment in 2008 by then-Gov. Timothy Kaine, she worked in senior leadership positions for several health-care organizations, including Sentara Healthcare, Anthem Blue Cross Blue Shield of Virginia and Physicians for Peace.

Dr. Remley’s background includes serving as Chief Executive Officer of Physicians for Peace and Chief Medical Officer of Operation Smile Inc.; 15 years as an attending physician in the emergency department at

Children’s Hospital of The King’s Daughters; teaching at three institutions of higher education, including at EVMS, where she is Associate Professor of Pediatrics and Health Professions; numerous awards for leadership, health-care management and public-health advocacy.

Steven D. Gravely, JD, MHA, is a healthcare attorney with over 25 years of experience representing health care providers. He holds a Master’s Degree in Health Administration and worked in several hospital systems prior to beginning the practice of law. During college, he was a volunteer firefighter and EMT with the Williamsburg, VA Fire Department. For the past 6 years, Mr. Gravely has been heavily engaged in emergency preparedness and response for health care providers and other critical infrastructure industries. He provides legal analysis of the complex issues that arise during disasters and also facilitates large workgroups of government and private sector representatives on legal and policy issues related to disaster preparedness.
